# Organization guidelines for winter series 2025/2026

# ČSOB winter series 06.12.2025 (St. Nicolaus)

#### Article I

#### **Basic Provisions**

(1) BE COOL, s.r.o. with registered office at Krajinská 37, 821 06 Bratislava, ID No. 35 75 14 52 as the organizer of the Event, issues in accordance with § 6 of Act No. 1/2014 Z.z. on the organization of public sports events and on the amendment and supplementation of certain laws, this Organizational and Visitor Regulations of the sports event named ČSOB winter series 06.12.2025 – St. Nicholas edition (hereinafter referred to as "Event") organized by BE COOL, s.r.o. (hereinafter referred to as "Organizer").

The Event is a public sports event accessible to the public, which takes place for participants based on their registration with the Organizer, in public areas - communications temporarily used for the realization and organization of the Event located around Eurovea according to the approved route map of the Event published on the website <a href="mailto:bratislavamarathon.com">bratislavamarathon.com</a> (hereinafter referred to as "Event website").

- (2) The purpose of the organizational and visitor regulations of the Event is to regulate the safety, health protection, property and environment of the participants of the Event and details related to the participation of spectators in the Event.
- (3) These organizational and visitor regulations of the Event determine the binding rules of conduct for participants at the Event.
- (4) Every participant at the Event is obliged to observe the duties, guidelines and instructions:
- a) stated in these organizational regulations of the Event.
- b) stated on the information leaflet issued for the Event and in the propositions stated on the Event website, which are available at the presentation of the Event participants,
- c) safety signs at the venue of the Event,
- d) members of the organizing service, members of the private security service, members of the Police Force and Municipal (local) Police, who ensure the organization of traffic on public roads and the protection of public order at the Event,
- e) members of the emergency medical service, fire brigades and other rescue forces.
- (5) A participant of the Event is a natural person who, due to the Event, is present at the venue of the Event or in its vicinity, especially a spectator, a person who participates in the Event in connection with the performance of sports activities, a person who participates in the Event in connection with the organization of the Event, a person who participates in the Event in connection with the performance of their profession (member of the Police of the Slovak Republic, Fire and Rescue Service, rescuer, journalist, photographer, member of a TV crew, radio or other media, etc.), an accredited person.
- (6) The participant takes part in the Event at their own risk.

Slovak Republic by the organizer of the Event, by intentional or negligent conduct of natural persons who are in an employment or other contractual relationship with the organizer of the Event, and the participant of the Event reported the damage to the organizer of the Event.

(8) The main organizer organizes and manages the organization of the Event and ensures the fulfillment of tasks according to the Organizer's instructions. The security manager is a professionally qualified organizer whom the Event Organizer has designated to organize and manage the activities of the organizing service, prepare, manage, perform and evaluate security measures at the venue of the Event. An organizer is a natural person designated by the Organizer, dressed in a reflective vest with the prominent inscription "ORGANIZER" and a number.

#### Article II

### Powers of the Organizer

### The organizer is authorized

- a) to ascertain whether only a natural person authorized to participate in the Event wishes to do so,
- b) to ascertain by sight, touch or technical means whether a natural person entering the premises of the Event, including hand luggage, or on their person, has a firearm, pyrotechnic product or other item that can make an attack on the body more forceful, alcoholic beverages, if the municipality has issued a ban on the sale, serving or consumption of alcoholic beverages at the event, drugs or psychotropic substances,
- c) to prevent or prohibit entry to the Event for a natural person who brings into the premises of the Event a firearm, pyrotechnic product or other item that can make an attack on the body more forceful, alcoholic beverages, if the municipality has issued a ban on the sale, serving or consumption of alcoholic beverages at the Event, drugs or psychotropic substances,
- d) to prevent or prohibit entry to the Event for a natural person who is visibly under the influence of alcohol, drugs or psychotropic substances,
- e) to prevent entry to the Event for a natural person whose court has imposed a restriction within the framework of probation supervision or whose relevant authority has imposed a restrictive measure,
- f) to warn participants of the Event about the inappropriateness of their behavior and to demand that they desist from it, if their behavior violates public order or disrupts the peaceful course of the Event,
- g) to instruct participants of the Event to leave the Event without compensation for the entrance fee, if after a warning they continue in inappropriate behavior, violate public order or disrupt the peaceful course of the Event,
- h) to escort participants of the Event and prohibit their further participation in the Event without compensation for the entrance fee, if they did not obey the instruction to leave the Event.

i) to request proof of identity of the event participant in connection with their breach of the event participant's obligations, record and hand over their data to other authorized persons and authorities.

#### Article III

**Duties and Prohibitions for Event Participants** 

- (1) The participant of the Event is obliged to
- a) observe the instructions of the Event Organizer, the organizing service, members of the Police Force, Municipal (local) Police and members of the private security service ensuring the protection of public order at the Event, and refrain from anything that would violate public order or the proper and peaceful course of the Event,
- b) refrain from consuming alcoholic beverages during the Event, if the municipality has issued a ban on the sale, serving or consumption of alcoholic beverages at the Event, refrain from consuming drugs and psychotropic substances during the Event,
- c) tolerate the actions of the Organizer, organizer, members of the Police Force, Municipal (local) Police or a member of the private security service related to the breach of the participant's duties,
- d) after the end of the Event, disperse peacefully and leave the venue of the Event.
- (2) The participant of the Event is prohibited from bringing to the Event:
- a) firearms and other weapons and objects that can make an attack on the body more forceful (e.g., daggers, swords, bayonets, knives, sticks, poles, batons, glass bottles, chairs, stands) with the exception of when they have the consent of the Event Organizer to bring in the mentioned weapons and objects,
- b) explosives and pyrotechnic products,
- c) sprays, corrosive, flammable and coloring substances or other substances harmful to health,
- d) alcoholic beverages, if the municipality has issued a ban on their sale, serving or consumption of alcoholic beverages at the Event,
- e) drugs or psychotropic substances,
- f) racist, vulgar, offensive and morally objectionable banners, leaflets and other promotional materials,
- g) mechanically powered machines and tools causing noise,
- h) animals,
- i) laser pointers and other objects whose light and other radiation negatively affect the participants of the Event, including competing athletes and referees.
- j) it is forbidden to visit the event under the influence of alcohol or psychotropic substances.
- (3) The prohibitions stated in paragraph 2 letters a), b), c), g), h), i) and j) do not apply to natural persons who have the consent of the Event Organizer to bring the mentioned weapons and objects to the Event.
- (4) The participant of the Event is prohibited from

- a) having their face covered in a way that prevents their identification, if a service intervention is being carried out against them by members of the Police Force and a member of the Police Force has called on them to uncover their face.
- b) using state symbols of foreign states or their predecessors in a derogatory manner or in another way that can incite to disruption of public order or endanger the proper course of the Event,
- c) uttering and chanting racist, vulgar, offensive and morally objectionable words and slogans,
- d) entering the premises where the Event is taking place, which are not intended for spectators (visitors) of the Event,
- e) throwing objects endangering the health and safety of the participants of the Event in the premises of the Event
- f) starting fires and using pyrotechnic products in the premises of the Event,
- g) causing public scandal,
- h) polluting the venue of the Event with poster decorations, commercial and advertising announcements,
- i) destroying and damaging the venue of the Event and its equipment,
- j) harassing and physically attacking and beating participants of the Event,
- k) selling goods and services without the permission of the Event Organizer,
- I) making audio and video recordings of the Event, unless the Event Organizer has given the participant of the Event permission for this activity.

#### Article IV

Entry and Stay of the Participant at the Event

- (1) Only a natural person who presents a start number or other document authorizing them to enter the Event may enter the area where the Event is taking place.
- (2) At the request of a member of the organizing service, a member of the private security service or a member of the Police Force and Municipal (local) Police, who ensure the protection of public order at the Event, the participant is obliged to present a start number or other document authorizing them to enter the Event at any time. In case they do not have a start number or other document, they are obliged to leave the area where the Event is taking place. If they do not do so, they may be escorted from the Event.

## Article V

**Escorting a Participant from the Event** 

The Organizer, a member of the organizing service, a member of the private security service or a member of the Police Force and Municipal (local) Police, who ensure the protection of public order at the Event, may escort a participant from the Event without compensation for the starting fee, who:

a) does not observe the instructions of the Event Organizer, the organizing service, members of the Police Force, Municipal (local) Police and members of the private security service ensuring the protection of public order at the Event,

- b) disrupts public order or the proper and peaceful course of the Event,
- c) consumes alcoholic beverages during the Event, if the municipality has issued a ban on their sale, serving or consumption of alcoholic beverages at the Event,
- d) consumes drugs and other psychotropic substances during the Event,
- e) refuses to uncover their face at the call of a member of the Police Force,
- f) uses state symbols of foreign states or their predecessors in a derogatory manner or in another way that can incite to disruption of public order or endanger the proper course of the Event,
- g) utters and chants racist, vulgar, offensive and morally objectionable words and slogans, or presents them on banners, posters and the like,
- h) enters the premises of the Event which are not intended for spectators (visitors) of the Event, for example, premises intended for competing athletes, members of sports teams, referees, organizers,

- i) throws objects endangering the health and safety of the participants of the Event in the premises of the Event,
- j) starts fires and uses pyrotechnic products in the premises of the Event,
- k) causes public scandal,
- I) pollutes the venue of the Event (including poster decorations, commercial and advertising announcements),
- m) destroys and damages the venue of the Event and its equipment,
- n) harasses and physically attacks and beats participants of the Event,
- o) sells goods and services without the permission of the Event Organizer.

#### Article VI

#### **Effectiveness**

- (1) In other rights and obligations of the Event participants not specifically regulated in these Organizational and Visitor Regulations of the Event, the relevant provisions of Act No. 1/2014 Z.z. on the organization of public sports events, as amended, apply.
- (2) These Organizational and Visitor Regulations of the Event come into effect on 06.12.2025
